## RAPHAEL ACADEMY CLASSROOM MAKEOVER

In April of 2021, Raphael Academy was nominated by SCNZ architects for a grant from the <u>Association for Learning Environments</u>. After being selected as a recipient, the association brought together vendors from all over Louisiana - including Workplace Solutions, Frost Barber, and AXI Education Solutions - to completely transform our Transition (high school) classroom. Their generosity also extended into the Riley Room where they provided much needed bookshelves for our library and school resources. We are so grateful to the Association for Learning Environments and SCNZ for their support. This classroom is truly state of the art!

## **GUILD GARDENS**

Through a generous grant from an anonymous donor, we will be able to complete the installation of Guild gardens at the Town Center. This grant will allow us to purchase picnic tables, raised garden beds, an irrigation system, a storage shed, and build the foundation for our new greenhouse. These much needed items are the final touches for our Urban Gardening Program, through which Guild members grow edible and decorative flowers, vegetables and herbs for their cooking program and Dragonfly Café. Additionally, these funds will support the replacement of fencing that was blown or knocked down during hurricane Ida at both the school's playground and the Town Center.

#### **RIBBON CUTTING**

On Wednesday, October 20th we celebrated the completion of the Town Center Project. The Ribbon Cutting Ceremony was attended by our biggest financial supporters, Guild parents, Board members, Guild members, Raphael Academy students, and City leaders like Councilman Jay Banks and the Honorable Mayor LaToya Cantrell. Following the ceremony Guild members danced the afternoon away to pop tunes spun by DJ Oliver Sobrino, a former Guild member who has formed OMG (Oliver Music Group). The Town Center marks the completion of Phase II of our efforts to create an urban lifesharing community for the Greater New Orleans community.
